JOHN MILLER ANNOUNCES RETIREMENT AS EXECUTIVE DIRECTOR

John Miller expressed his appreciation toward the staff of the facility and announced that after 41 years that he will be retiring as the Executive Director, effective June 29, 2018. The Board applauded the work Mr. Miller has done for the community.

FORMATION OF SUB-COMMITTEE TO SEARCH FOR EXECUTIVE DIRECTOR

Board Chair Money distributed a copy of Mr. Miller's employment agreement and his job

description. Board Chair Money opened the floor to other Board Members input on the job description and hiring process. Mr. Miller gave a brief background of his hiring process. Mr. Godfrey informed the Board that interviews for the Executive Director Position could be done during a closed session to protect the applicant's anonymity. Mr. Godfrey suggested a subcommittee to narrow the field of applicants down to the number of interviews for the full Board to interview in the closed session. A discussion was had concerning who should be included on the sub-committee and the hiring process.

Mayor Lewis made a motion to appoint a sub-committee of (6) six and suggested it consist of representatives from all cities in the District:
